- I registered to attend the online Known World Heraldic and Scribal Symposium (January 14-16, 2022.)
- I'm working on a paper on the heraldry displayed in the 1938 movie *The Adventures of Robin Hood*

Laurel Activities; Letter of Acceptance and Returns (LoAR) January 8, 2022

- The Laurel Queen of Arms submitted a great many technical changes to the Standards for Evaluation of Names and Armory (SENA), the rules by which submissions are judged.
- The Wreath Sovereign of Arms ruled that a new monster that combines identifiable elements from different animals and monsters is registerable as a charge, even if it recreates a named heraldic monster which is demonstrated to be a wholly post-period invention in real-world heraldry. For example, there is a pattern of combining the top half of a camel with a fish tail to make a sea-camel.
- The Pelican Sovereign of Arms ruled that a registerable personal name must be made up of at least two name phrases: a given name and at least one byname (which may appear to be a second given name). Each name phrase must be grammatically correct for its position in a name.
